SECTION 4: FIRST AID MEASURES

4.1. Description of first aid measures

Remove all sources of ignition. Ventilate well. Stop leak if safe to do so. Use spark-proof tools and explosion-proof equipment. Contain spillages with sand, earth or any suitable adsorbent material. Transfer to a container for disposal.

7.1. Precautions for safe handling

Always remove oil with soap and water or skin cleaning agent, never use organic solvents. Do not use oil-contaminated clothing or shoes, and do not put rags moistened with oil into pockets.

Technical measures: Use work methods which minimise oil mist production.

Technical precautions: When working with heated oil, mechanical ventilation may be required.

Technical measures for safe storage: Keep away from heat, sparks and open flame.

Storage conditions: Store in tightly closed original container in a dry, cool and well-ventilated place. Protect against direct sunlight.
