SECTION 4: FIRST AID MEASURES

4.1. Description of first aid measures

7.1. Precautions for safe handling

Always remove oil with soap and water or skin cleaning agent, never use organic solvents. Do not use oil-contaminated clothing or shoes, and do not put rags moistened with oil into pockets.

Technical measures: Use work methods which minimise oil mist production.

Technical precautions: When working with heated oil, mechanical ventilation may be required.

Technical measures for safe storage: Keep away from heat, sparks and open flame.

Storage conditions: Store in tightly closed original container in a dry, cool and well-ventilated place. Protect against direct sunlight.
